## What investment services and advice can you provide me?

Auxano offers a team approach dedicated to unsurpassed client service and relationship commitment. We offer investment advisory services to retail and institutional clients. Our goal is to support you and your family with a comprehensive understanding of your financial and personal world. We offer financial planning for complex situations through the integration of investments, estate planning, lifestyle planning and family office convenience. In addition to investment advisory services, we offer cash flow planning, estate planning review, tax coordination, and other special projects. **Accounts:** We service retail nonqualified and qualified accounts as well as all manner of institutional accounts. **Investments:** Our investment portfolios use a combination of mutual funds, exchange traded funds, stocks, bonds, Hedge Funds, Private Equity, Venture Capital, and Real Estate. We also use selected third-party investment managers for Separately Managed Accounts.

**Monitoring:** We will discuss your investment goals, design with you a strategy to achieve your investment goals and monitor portfolios and securities in your accounts on an ongoing basis. We also meet with you at least annually depending on your needs. **Investment Authority:** We provide our services on a perpetual discretionary and nondiscretionary basis as requested. We execute investment recommendations and specific transactions, in accordance with your investment objectives, with or without your prior approval, based upon discretionary or nondiscretionary account management status. Our engagement will continue until you notify us otherwise in writing. **Account Minimums and Other Requirements:** We do not have a strict account minimum, but most clients have at least \$1,000,000 under management with us.

## What fees will I pay?

Auxano provides investment advisory services for a fee based on a percentage of assets under management. This fee will be collected at the end of each quarter and is calculated as a percentage of the value of the cash and investments in your account[s] that we manage. Note that the fee rate is on a sliding schedule and as your assets increase, your effective fee rate declines. **Conflicts of Interest:** The more assets you have in the advisory account[s], the more you will pay us. We therefore have an incentive to increase the assets in your account in order to increase our fee. **Other Fees and Costs:** In addition to our advisory fee, clients may be responsible for custodian fees, account maintenance fees, fees related to mutual funds, and other transactional fees. Some of our Investment Adviser Representatives also serve as insurance agents. Through their role as such they may sell, for commissions, various insurance products.

**You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.**

### **What Are Your Legal Obligations to Me When Acting as My Investment Adviser? How Else Does Your Firm Make Money and What Conflicts of Interest Do You Have?**

**When we act as your investment adviser**, we are required to act in your best interest and not put our interests ahead of yours. While our fee-only compensation structure seeks to remove many conflicts of interest, charging a percentage fee on assets under management can create circumstances which some investors may consider conflicts. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. We will recommend that you open your account with a specific custodian, where we have an institutional relationship and may receive economic benefits. However, you ultimately decide where to open your accounts. Choosing a different custodian may result in the loss of quality of service and/or ability to obtain favorable prices. As noted above, certain investment adviser representatives of our firm are also licensed insurance agents and may earn commissions on various insurance products. We have a conflict of interest in recommending these products to you because of the potential for additional revenue. We have a financial incentive to recommend that you rollover retirement plan assets into an IRA we manage; however, we seek to educate you on your options and the fees and benefits associated with each choice and then allow you to choose which you feel is in your best interest.
